## UGANDA SUPPORT TO MUNICIPAL INFRASTRUCTURE DEVELOPMENT-ADDITIONAL FINANCING (USMID-AF) PROGRAM. BID NOTICE UNDER OPEN NATIONAL BIDDING FOR CIVIL WORKS OF INFRASTRUCTURE PROJECTS AND CONSULTANCY SERVICES FOR SUPERVISION OF THE CIVIL WORKS IN LIRA CITY, MOROTO MUNICIPAL COUNCIL AND APAC MUNICIPAL COUNCIL (CLUSTER TWO)

- The Government of Uganda (GOU) through the Ministry of Lands Housing and Urban Development (MLUD) has allocated funding from the World Bank to be used for the acquisition of contractors for civil works sub projects (roads and economic infrastructure) and consultancy services for design review and supervision of the civil works under Uganda Support to Municipal Infrastructure Development Projects (USMID-AF) in cluster two of Lira, Moroto and Apac.
- Lira City on behalf of the three entities of Lira, Apac and Moroto intend to apply part of the funds to develop selected infrastructure projects in the three participating entities and engage consultants to review the designs and supervise the civil works.
- Lira City now invites sealed bids from eligible and competent bidders for implementation of selected infrastructure sub-projects in the City/Municipalities of Lira, Moroto and Apac and consultancy services for supervision of the civil works as below;

Bidding will be conducted in accordance with the Open National bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, (PPDA) 2003 and the Local Government Public Procurement and Disposal of Public Assets Regulations 2006, as amended. The bidding process is open to all bidders from eligible countries.

- The Procurement has been packaged into a cluster and the participating City/Municipal councils are jointly procuring a contractor for the cluster and award will be made to the best evaluated responsive bidder for the entire cluster. Bidders who will bid for less than the whole cluster will be considered non responsive and the successful bidder will sign a contract with each of the three participating entities and foreign bidders will be required to reserve at least 30% of the value of works through sub-contracting of works and supply of materials, equipment and services to national and resident providers.

- The detailed scope, description of the works, terms of reference, terms & conditions for bidding are detailed in the respective bidding document.
- The bidding documents in English may be purchased by interested bidders on the submission of a written application to the above City Council office and upon payment of a non-refundable fee **Ugx: 500,000 (five hundred thousand shillings)** only for civil works and **Ugx: 200,000 (two hundred thousand shillings only)** for consultancy. After payment proceed to Lira City cashier and present a bank slip to obtain a general receipt which you will then present to the Procurement and Disposal Unit at address at (9a) below. The method of payment will be by cash payment to Lira Municipal General Fund Account No. 2291049747 with KCB BANK –Lira Branch.
- Bids must be delivered to the address below in No. 9© at or before **12:00 noon on 8<sup>th</sup> Jan, 2021**. All bids must be accompanied by a bid security of **Ugx: 600,000,000 (Six hundred million shillings)** from a reputable financial institution in Uganda (in form of a bank guarantee). Bid securities will be valid until 1<sup>st</sup> April, 2021. Late bids shall be rejected. Bids will be opened in the presence of the bidders representatives who may choose to attend at the address below in No. 9(d) at **12:30 noon on 8<sup>th</sup> Jan, 2021**.
